April 17, 2018

The Board of County Commissioners of Goshen County, Wyoming met in regular session on the above date at 9:00 am at the Goshen County Courthouse with the following members present, Chairman Carl Rupp, Vice Chairman Wally Wolski and Commissioner John Ellis and Cindy Kenyon, County Clerk and Clerk of the Board. Commissioner Wolski moved to approve the agenda and minutes of the last meeting as presented and the updated warrant report, seconded and passed.

The Sheriff's report was accepted from Undersheriff Jeremy Wardell.

Mickey Conway from Northwest Regional Organizing Coalition of the Laborers' International Union provided information on the Wyoming Laborer's Union.

Chairman Rupp presented information on the history and loss of the Wyoming Consensus Block Grant program. He also discussed the need for grants.

The Treasurer's report was accepted from Maxine Mitchell. Commissioner Ellis moved to approve the County Treasurer to fill a vacant position, seconded and passed. Commissioner Wolski moved to approve the Treasurer's report, seconded and passed.

The Road and Bridge report was accepted from Jerry Hort, Gary Childs, Bob Taylor and Val Hankins. Craig Fiscus spoke regarding Road 74T. Resident Karen Johnson was present for an update regarding Road 57. Deputy County Attorney Dana Lent clarified the issues with Ms. Johnson's road.

Residents Delfino and Margaret Martinez requested information on the safety issues of junk and vehicles stored in their neighborhood.

The County Clerk's report was accepted from Cindy Kenyon. Commissioner Ellis moved to approve the County Clerk filling a vacant position, seconded and passed. Commissioner Wolski moved to approve, upon recommendation of the County Clerk, to keep the voting districts the same; seconded and passed.

The Commission discussed the upcoming decision to set Elected Officials Salaries for the next four years.

Karmen Rossi with Congresswoman Cheney's office provided an update on Veteran's medical bill payment issues and other projects in Cheney's office.

Commissioner Wolski provided an update on "Honoring the Spirit of the Great Northern Plain" event which commemorates the 150th Anniversary of the Signing of the Treaty of Fort Laramie.

Commissioner Ellis moved to enter executive session at 11:46 am to discuss a personnel issue, seconded and passed. The Commissioner left executive session at 12:31 pm.
