RESOLUTION NO. 2017-08

A RESOLUTION AUTHORIZING THE COUNTY SURVEYOR TO PRODUCE A MAP DEFINING THE ORDER GRANTING AND DENYING SUMMARY JUDGMENT DOCKET #CV-2013-136-DC

WHEREAS; the location of corporate boundaries of municipalities within Goshen County is vitally necessary to allow County officials to perform their duties relating to jurisdiction, elections, taxation and other matters; and,

WHEREAS; the District Court, Eighth Judicial District in and for Goshen County, Wyoming entered its Order Granting And Denying Summary Judgment, in Docket No. CV-2013-136-DC, on August 12, 2016, the location of the corporate boundary of the City of Torrington in the area west of the centerline of West E Street and north of 19th Avenue below the Southwest boundary of the Burlington Northern And Sante Fe Railroad right-of-way is uncertain and disputed; and,

WHEREAS; the Goshen County Board of Commissioners has determined that it is necessary that the current location of the boundary between the corporate limits of the City of Torrington and unincorporated Goshen County be determined by the Goshen County Surveyor on behalf of Goshen County to resolve such uncertainty and disputes.

NOW THEREFORE BE IT RESOLVED by the County Board of Commissioners to authorize and direct the Goshen County Surveyor to perform a boundary survey of the current westerly corporate boundary of the City of Torrington between 15th Avenue and the Southwest boundary of the Burlington Northern And Sante Fe Railroad right-of-way, in accordance with and as determined by the District Court, Eighth Judicial District, in and for Goshen County, Wyoming, in its Order Granting And Denying Summary Judgment, in Docket No. CV-2013-136-DC, filed August 12, 2016, and all other relevant evidence and records.

BE IT THEREFORE FURTHER RESOLVED that upon completion of such boundary survey, the Goshen County Surveyor is authorized and directed to record a map or plat and legal description of such boundary survey to be binding upon and used by the elected officials of Goshen County, Wyoming in the performance of their official duties.


