The Board of County Commissioners of Goshen County, Wyoming met in regular session on the above date at 9:00 am at the Goshen County Courthouse with the following members present, Chairman Carl Rupp, Vice Chairman Wally Wolski and Commissioner John Ellis and Cindy Kenyon, County Clerk and Clerk of the Board. Commissioner Wolski moved to approve the agenda and minutes of the last meeting as presented and updated warrant report, seconded and passed.

The Sheriff's report was accepted from Sheriff Don Murphy and Lt. Jeremy Wardell.

The Commissioners presented a plaque to Sheriff Murphy honoring his retirement. Sheriff Murphy commented that a person wins the first election and their staff wins the others. Sheriff Murphy has served as Goshen County Sheriff for 25 years and has been in law enforcement here for 40 years. His exemplary service to Goshen County residents is greatly appreciated.

Chairman Rupp reported on items of interest from the WCCA Executive Committee meeting.

Commissioner Ellis moved to sign the purchase agreement with Union Pacific Railroad Company for the Adam Walter Botanical Park, seconded and passed. The land will remain a park.

Goshen County Economic Development Director Ashley Harpstreith updated the Commission on Economic Development projects and prospects. She also presented their \$7500 funding request and service agreement for the upcoming fiscal year.

The Treasurer's report was accepted from Maxine Mitchell.

The County Commissioners announced the winners of the Goshen County Commission Scholarships. New scholarships awarded are Megan Baker, Landen Fuller, and Bailey Surratt. The renewal scholarship was awarded to Noelle Chapman. Congratulations to all the students for their excellent essays and applications. Commissioner Wolski moved to award the scholarships, seconded and passed.

Commissioner Wolski provided an update on the Endow Committee projects.

Senior Center Director Linda Cockett requested \$5000 funding for the upcoming year. Also, she updated the Commission on services provided by the Senior Center.

Town of Lingle Mayor George Siglin described an issue with mosquito spraying. Bob Baumgartner with Goshen County Weed and Pest described the updated mosquito program.

County Surveyor Bob Taylor and County Planner Gary Childs presented the final plat for the Togy Subdivision upon recommendation of the County Planning Commission. Commissioner Wolski moved to approve the Togy Subdivision Plat, seconded and passed.
