**Description of ballot proposition to be voted on at the General Election:**

**Goshen County Economic Development Tax**

Shall Goshen County, Wyoming continue to impose for four (4) years an excise tax of one-quarter percent (.25%) upon goods and services subject to such tax, to be paid to the Goshen County Economic Development Corp. for the purpose of economic development within Goshen County?

**Campaign Expenditure Report**

ALL candidates must file a statement of campaign contributions only by August 14, 2018, (at least 7 days before Primary Election); contributions only by October 30, 2018 (at least 7 days before General Election); expenditures by August 31, 2018 (10 days after Primary Election); expenditures by November 16, 2018 (10 days after General Election).

All statements required under W.S. 22-25-101 and 22-25-106 shall be filed as follows:

(I) Any candidate for a municipal, county, judicial, school or college board office and any political action committee or candidate's campaign committee supporting such a candidate, shall file with the County Clerk;

(II) Any candidate for a state legislative or district judgeship office and any political action committee or candidate's campaign committee supporting such a candidate, shall file with the Secretary of State;

(III) Any candidate for statewide office shall file with the Secretary of State;

(IV) A county party central committee shall file with the Secretary of State and County Clerk;

(V) A state party central committee shall file with the Secretary of State;

(VI) Precinct committeemen and precinct committeewomen elected at the primary election shall not be required to file a statement of receipts and expenditures;

Anyone violating any provision of the Wyoming Campaign Practices Act may be guilty of a misdemeanor or felony resulting in a fine, incarceration, or both. Any corporation, person or organization violating the contribution limits or prohibited acts is subject to a civil penalty up to \$10,000. Civil action may be brought by any candidate adversely affected by the transgression, by any political party or by a prosecuting authority.

If you require assistance to vote by reason of blindness, disability, or inability to read or write, you may be given assistance by a person of your choice.
