Tuesday April 21, 2020

The Board of County Commissioners of Goshen County, Wyoming met in regular session on the above date at 9:00 am at the Goshen County Courthouse in the Commissioners Chambers with the following members present telephonically, Chairman John Ellis, Vice Chairman Cody Cox, Pinky Walter Commissioner and Cindy Kenyon, County Clerk and Clerk of the Board. The meeting was opened with the Pledge of Allegiance. Commissioner Walter moved to approve the agenda and minutes of the last meeting, seconded and passed.

This is the second audio live streamed meeting of the Commission which can be heard on YouTube via a link on the Commissioners' website. Public comment forms are available from the Commissioners' website or from the County Clerk. Public comment will be read at the end of agenda. Official information is available from Goshen County public health officials.

Sheriff Kory Fleenor presented his regular monthly report. The Sheriff submitted his earnings report for \$\$1930 and the Commissary account report. Commissioner Cox moved to approve the reports, seconded and passed. The Sheriff reports the Covid response in his office is moving smoothly.

County Treasurer Leticia Dominguez presented her regular monthly report. Commissioner Walter moved to approve the regular monthly report, seconded and passed. The Treasurer reports her office is running smoothly during the pandemic and courthouse closure. Treasurer Dominguez also asked about plans to reopen the courthouse. The Commissioners indicated a safe plan will be formed with input from the department heads and public health.

County Clerk Cindy Kenyon submitted her regular monthly report and an amendment to the Women Infant Child (WIC) grant program contract with the State of Wyoming. Commissioner Cox moved to approve the Clerks updated warrant report, seconded and passed. Commissioner Walter moved to approve the amendment to the WIC grant contract, seconded and passed. The amendment allows funds to increase the available wages of the WIC secretary.

No public comment forms were submitted.
