YOUNG UN'S RANCH ROUND UP

RULES

1. No Team Entry Fee
2. All Coaches and Team members (unless 5 years or younger) will pay event gate admission fee of \$5
3. Each Team shall consist of 4 members; ages of 5 -12. (Age as of August 7, 2020).
 - a. Only two members can be between the ages of 5-8
 - b. Only two members can be between the ages of 9-12
 - c. At least one team member must be female
 - d. Mutton Buster must weigh 60 # or less
4. Each Team will have a designated coach that will be in arena with team during run
5. Penalties will be assessed by Officials
6. Fastest time will win the Rodeo
7. Obstacle run order is:
 - a. Barrel Race
 - b. Brandin'
 - c. Ropin'
 - d. Goat Pennin'
 - e. Mutton Bustin'

DETAILS:

1. Each team will gather at start line.
2. When Announcer says "GO", Barrel Racer will get on stick horse and run Barrel Pattern.
3. Barrel Racer will cross the finish line & tag Calf Brander. Calf Brander will get branding iron. Announcer will call out color. Brander will dip iron in the color bucket and place brand on the calf (poster Board) and will place iron in water bucket.
4. Brander will tag Roper. Roper will Rope the Steer head on the hay bale. Roper gets 2 loops. If first loop is a catch, team will run to the Goat pen. If second loop is a catch, team will run to Goat pen. Each "empty loop" will be a 5 second penalty added to the final time.
5. Official at Goat Pen will open gate. While team is on the move, Announcer will call out Number. Team will find Goat with that number and get in pen. When gate is closed on the Goat pen, time will STOP!
6. Teams will move to the chutes for Mutton Bustin' portion of the event. Each Mutton Buster will nod and be turned out of chute into mini arena. Ride will be timed. Official will rate rankness of the sheep; this will only be used in the case of a time tie. No Spurs allowed but costumes are welcome to enhance performance!
7. Scores will be tallied.
8. Judges decisions are FINAL
9. Awards will be presented to the top 3 Teams.

2 nd Place Team	Each Member will receive Rope & \$15 Dominos Gift Card
3 rd Place Team	Each Member will receive a \$25 Dominos Gift Card
