

## **Ordinance: 307**

**An ordinance providing for the annual appropriation for the Town of Fort Laramie for the fiscal year (1) July 2021 to (30) June 2022.**

**WHEREAS**, Pursuant to the law of the State of Wyoming and the Ordinances of the Town of Fort Laramie, Wyoming; the Town Clerk/Treasurer, acting as the budget officer for the Town, has prepared the proposed budget for the Town for the fiscal year beginning July 1, 2021 and ending June 30, 2022.

**WHEREAS**, THE Town Council of the Town of Fort Laramie has thoroughly reviewed the budget prepared by the budget officer and has determined and hereby declares that it accurately reflects the proposed revenues and expenditures of the Town during the FY2021-2022 fiscal year.

**Now therefore, be it ordained by the town council of the Town of Fort Laramie Wyoming:**

Section: 1. ADOPTION OF THE FY 21-22 BUDGET: That certain documents, two (2) copies of which are on file in the office of the Town of Fort Laramie, Wyoming, being marked and designated as “Town of Fort Laramie FY 21-22 Consolidated Budget”, and the same are hereby adopted as the Budget of the Town of Fort Laramie, Wyoming for the fiscal year commencing July 1, 2021 and ending June 30, 2022: each and all of the provisions of such “Town of Fort Laramie, Wyoming” are hereby referred to, adopted and made part hereof as is fully set out in this ordinance.

Section: 2. Summary of the anticipated REVENUES AND EXPENDITURES: The following sums of money are anticipated as

revenues and expenditures for the Town of Fort Laramie, Wyoming, for the fiscal year beginning July 1, 2021 and ending June 30, 2022, to wit:


Section: 3. REQUIRED MILL LEVY, It is anticipated that an Eight Mill Levy property tax will be required for operation of the

General Fund of the Town of Fort Laramie, Wyoming and a copy of this Ordinance should be forwarded to the BOARD OF COUNTY COMMISSIONERS of Goshen County, Wyoming by the Town Clerk requesting that Eight Mill be Levied upon the Town of Fort Laramie for Town purposes.

Section: 4. SEVERABILITY, If any section, paragraph, clause or provision of this ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall affect any of the remaining provisions of this ordinance.




