<p>CONSTITUTIONAL AMENDEMENT A</p> <p>The Wyoming Constitution allows the state to invest state funds in equities such as the stock of corporations, but does not allow the funds of counties, cities and other political subdivisions to be invested in equities. The adoption of this amendment would allow the funds of counties, cities and other political subdivisions to be invested in equities to the extent and in the manner the legislature may allow by law. <p>CONSTITUTIONAL AMENDEMENT B</p> <p>Currently, the Wyoming Constitution requires Wyoming Supreme Court justices and district court judges to retire upon reaching the age of seventy (70). This amendment increases the mandatory retirement age of Supreme Court justices and district court judges from age seventy (70) to age seventy-five (75).</p> <p>FOR AGAINST</p>	<p><u>HOW TO VOTE FOR A CANDIDATE OR WRITE IN A NAME</u></p> <p>To vote for a person whose name is printed on the ballot, mark the oval immediately adjacent to the name of the person for whom you desire to vote. To vote for a person whose name is not printed on the ballot, write the name in the blank space provided for that purpose and <u>mark the oval</u> immediately adjacent to the name of the person.
