FOR YOUR INFORMATION: Find the tax district where you live, find the total assessed value of your property (located on your assessment notice - mailed in April).

If you multiply your total assessed value times each one of the figures above (in your tax district) you can see exactly where your tax dollars are going!

EXAMPLE: If your property value was 200,000 your total assessed value would be 19,000 - this is the amount that is used to calculate your taxes.

If you wanted to know how much of your tax dollars went to the college, and you live in tax district 0101. Then you would multiple 19000 x .00787 (.005 +.0005 + .0028) = \$148.20. This is the portion of your taxes that goes to the college.
